

STANDARD CROSS-TOWN AGREEMENT

This agreement is among the governing authorities of the University of Missouri-Columbia which hosts Military Science/Army ROTC, the governing authorities of Central Methodist College which does not host an Army ROTC unit, and Commandant, Army ROTC. It is the purpose of this agreement to make the Military Science/Army ROTC course available to qualified students of Central Methodist College who desire to earn appointments as commissioned officers in the United States Army.

AGREEMENT

1. Contingent upon acceptance of this agreement and upon the initial and continuing fulfillment of all the conditions enumerated in paragraphs 2, 3, 4 and 5 following, the Military Science Commandant will:
 - a. Provide Army ROTC instruction in the military course to qualified and selected applicants who are students of Central Methodist College. Army ROTC instruction will be provided to those selected students of Central Methodist College on the campus of University of Missouri-Columbia.
 - b. Enroll qualified students of Central Methodist College who are selected for Military Science as members of the Army ROTC detachment at University of Missouri-Columbia.
 - c. Provide uniforms, in accordance with the existing contract agreement between University of Missouri-Columbia and the Storekeeper of Military Science/Army ROTC, to University of Missouri-Columbia for all Army ROTC cadets who are enrolled as members of the Army ROTC detachment at University of Missouri-Columbia.
 - d. Provide subsistence allowance in accordance with existing policies to all Army ROTC cadets who are enrolled as members of the Military Science/Army ROTC detachment at University of Missouri-Columbia.
 - (1) To University of Missouri-Columbia for all Army ROTC cadets on scholarship status who are enrolled as members of the Army ROTC detachment at University of Missouri-Columbia.
 - (2) To Central Methodist College for all Army ROTC cadets on scholarship status who are enrolled as members of the Army ROTC detachment at University of Missouri-Columbia if a separate education service agreement exists between the Department of the Army and Central Methodist College.
2. Contingent upon the acceptance of this agreement and upon fulfillment of the conditions enumerated in paragraph 1 above, the governing authority of University of Missouri-Columbia agree to:
 - a. Furnish necessary uniforms and accessories to all enrolled members of the Army ROTC unit which it hosts.
 - b. Provide adequate classroom and related administrative facilities to support the military science instruction of all enrolled members of its Army ROTC unit who received instruction on its campus.
 - c. Report estimated and actual costs of tuition and fees for each fiscal year to the Army ROTC detachment at University of Missouri-Columbia. This report will be the basis for funding obligations for each fiscal year.
3. Contingent upon the acceptance of this agreement and upon fulfillment of the conditions enumerated in paragraphs 1 and 2 above, the governing authorities of Central Methodist College agree to:
 - a. Include in appropriate publications announcement of the military science course of Army ROTC available to its students.
 - b. Grant appropriate academic credit applicable toward graduation for the successful completion of courses offered by the Department of Military Science at University of Missouri-Columbia.
 - c. Report if a separate educational services agreement exists between the Department of Military Science and Central Methodist College, the estimated and actual costs of tuition and fees for each fiscal year to the

Army ROTC detachment at University of Missouri-Columbia. This report will be the basis for funding obligations for each fiscal year.

4. The governing authorities of University of Missouri-Columbia and Central Methodist College will either negotiate a formal written agreement whereby University of Missouri-Columbia transfers tuition and fees to Central Methodist College for those students on scholarship status from Central Methodist College enrolled in Army ROTC at University of Missouri-Columbia; or concur that a separate educational services agreement between the Department of the Army and Central Methodist College is desired.
5. The governing authorities of Central Methodist College affirm that:
 - a. The following regional association accredits it (as a baccalaureate degree granting institution): The North Central Association of Colleges and Schools, Commission on Institutions of Higher Education.
 - b. For good and valid mutual consideration, and as a condition precedent to acceptance and discrimination in any way with respect to the admission or subsequent treatment of students on the basis of race, color, sex, or national origin. It is further mutually agreed that Cadet Command may regard a violation of this covenant, as a breach of this agreement, justifying termination thereof, at no cost to the government.
6. All parties agree that:
 - a. This agreement becomes effective upon execution of all signatories.
 - b. This agreement may be terminated at the end of any school year by any of the parties hereto by giving six (6) months prior notice of such intent to both other parties.
